By-Law 2.1 to 2.9	14-15
CURRENT WORDING / LIBELLÉ ACTUEL :	
2.1 The registration fees shall be set annually by the Association.	
2.2 Residency status will be checked vigorously by the Association.	
2.3 A player shall be registered in the category appropriate to his age, and the limits shall correspond with those of the New Brunswick Minor Hockey Council.	
2.4 Fees must be paid in full at registration or by a deposit of \$100.00 at registration plus mandatory post-dated cheques for the balance (all dated before November 30th). Cheques are made payable to the RNMHA. Only exception is the players that have requested financial support (KidSport or Jumpstart).	
2.5 Any families that need additional financial accommodations must make a formal request with the Finance Committee and abide by the policy drafted by the Finance Committee and approved by council.	
2.6 A \$100.00 late fee will be imposed on all registrations made after Registration Sessions.	
2.7 A \$20.00 fee will be charged for all non-sufficient funds (NSF) cheques.	
2.8 Refunds of registration fees for players, who decide to quit the Association for whatever reason after having paid their registration, may be given according to the following formula: <ul style="list-style-type: none">• on or before the start of the season: Full refund• on or before November 15th: (total – 75\$) x 1/3 refund• on or before January 10th: (total – 75\$) x 1/4 refund• after January 10th: no refund.	
2.9 Teams will be asked to participate in fundraising events as deemed necessary to increase the Associations revenues.	
2.10 No individual team fundraising will be permitted. Any fundraising must be approved by the Executive Committee. The only exception will be the sale of half and half tickets during a team's home games.	

2.11 A jersey deposit of \$150.00 (Post dated cheque dated April 1st) will be required at the start of the season from each participant.

PROPOSED WORDING / LIBELLÉ PROPOSÉ :

2.1 The registration fees shall be set annually by the Association.

2.2 The Finance Committee is responsible for drafting and implementing the fee schedule and payment options for registrations subject to approval by the Board of Directors, for each hockey season. This includes policies regarding late fees, financial assistance, refunds and any other financial concerns regarding registrations.

2.3 Any families that need additional financial accommodations must make a formal request with the Finance Committee and abide by the policy drafted by the Finance Committee and approved by the Board of Directors.

2.4 Each team and its members are responsible for fulfilling their fundraising obligations as instructed by the Association.

2.5 No individual team fundraising will be permitted. Any fundraising must be approved by the Executive Committee. The only exception will be the sale of half and half tickets during a team's home games.

2.6 A jersey deposit of \$150.00 (Post dated cheque dated April 1st) will be required at the start of the season from each participant.
